13 Description of Equipment or Protective System:

The AutroVu® Model AV20 Universal Display unit is designed to be used with the GT3000 Toxic Gas Detector or PIRECL Combustible Gas Detector. The AV20 functions as a pass through device, reading the linear 4-20 mA dc output signal from the gas detector. The detected gas concentration is indicated on an alphanumeric display. The AV20 automatically detects the gas type and operating range of the sensor to which it is connected via the HART signal.
